

Corrections Corporation of America Enters Into Agreement with Colorado for Maximum Security Inmates to be Housed at CCA's Tallahatchie County Correctional Facility

Nashville, Tenn., June 1, 2004 - Corrections Corporation of America (CCA) (NYSE: CXW), the nation's largest provider of corrections management services to government agencies, announced today that it has entered into an agreement to manage a population of up to 128 Colorado maximum-security inmates at the Company's owned and operated Tallahatchie County Correctional Facility, located in Tutwiler, Mississippi. There currently are approximately 35 Colorado inmates at the Tallahatchie facility, which is expected to reach 128 over the next several weeks.

The terms of the contract include a one-year agreement effective through June 30, 2005, with four one-year renewal options. CCA has a long-standing partnership with Colorado and presently owns and operates four correctional institutions in Colorado and manages nearly 3,000 Colorado inmates in those facilities. The new agreement is not expected to have a material impact on CCA's previous financial guidance.

The 1,104-bed Tallahatchie prison presently houses approximately 310 inmates from Hawaii along with approximately 35 local county inmates. An additional population of approximately 115 Hawaiian inmates is expected at the facility by June 30, 2004. The Company is in discussions with a number of additional potential customers to utilize the remaining capacity at the Tallahatchie facility.

CCA is the nation's largest owner and operator of privatized correctional and detention facilities and one of the largest prison operators in the United States, behind only the federal government and four states. CCA currently operates 65 facilities, including 38 company-owned facilities, with a total design capacity of approximately 66,000 beds in 20 states and the District of Columbia. CCA specializes in owning, operating and managing prisons and other correctional facilities and providing inmate residential and prisoner transportation services for governmental agencies. In addition to providing the fundamental residential services relating to inmates, our facilities offer a variety of rehabilitation and educational programs, including basic education, religious services, life skills and employment training and substance abuse treatment. These services are intended to reduce recidivism and to prepare inmates for their successful re-entry into society upon their release. We also provide health care (including medical, dental and psychiatric services), food services and work and recreational programs.
