

State of Texas Renews Corrections Management Contract with Corrections Corporation of America at Two Pre-Parole Transfer Facilities Under A Competitive Bid Process

Nashville, Tenn., January 20, 2004 - Corrections Corporation of America (CCA) (NYSE: CXW), the nation's largest provider of corrections management services to government agencies, has announced that the Texas Department of Criminal Justice has awarded CCA contracts for the continued management of the 2,100-bed Mineral Wells Pre-Parole Transfer Facility located in Mineral Wells, Texas and the 200-bed Bridgeport Pre-Parole Transfer Facility located in Bridgeport, Texas.

The new contracts each have a three-year base term with four one-year renewal options and were awarded after a competitive procurement process. CCA has managed each of these facilities since 1995.

John Ferguson, President and Chief Executive Officer of CCA stated, "We appreciate the continued confidence the State of Texas has placed in our company. These two management contracts, coupled with the six new and one renewed Texas prison contracts we were awarded three months ago send positive reinforcement to our employees and management that we are meeting the high level of service and operational integrity that our government partners demand of us."

We specialize in owning, operating, and managing prisons and other correctional facilities and providing inmate residential and prisoner transportation services for governmental agencies. In addition to providing the fundamental residential services relating to inmates, our facilities offer a variety of rehabilitation and educational programs, including basic education, religious services, life skills and employment training and substance abuse treatment. These services are intended to reduce recidivism and to prepare inmates for their successful re-entry into society upon their release. CCA also provides health care (including medical, dental and psychiatric services), food services and work and recreational programs.
